### EUROPEAN AND INTERNATIONAL STUDENTS 18 YEARS OF AGE AND OVER

EDCN accepts students for the three last grades of dance training course (6th, 7th and 8th grade) who have completed 18 years of age by the beginning of the school year. Admission and selection of students is by audition, either in presential or alternatively by video submission. The video should include specific sections from classical ballet and contemporary dance class.

Auditions and video applications are assessed by a panel appointed by the school's direction.

Fees for students from European and Portuguese speaking countries – **2,500 euros per annum**. Fees for International students – **3,500 euros per annum**.

**Fees should be paid in two installments, with the first installment (50%) due at the time of the enrollment (not refundable), and the second installment (50%) due at the time of the registration.** EDCN reserves the right to refuse admission of students due to failure of payment.

EDCN offers scholarships at International Dance Competitions as awards to successful competitors wishing to attend the school. The school also offers exemption or reduction of annual tuition for students whose parental income is insufficient to cover school fees. Parents who wish to apply for exemption or reduction have to provide official documents of income, which are then assessed by the schools' administration. Students will be informed of the final decision within 5 working days by email.

Portuguese language classes are available for European and International students but are however dependent on the availability of teaching staff, which is reviewed annually.

EDCN accepts no responsibility for authorisation of necessary visas and resident permits for European and International students who wish to attend the school, as well as meals, accommodation and any goods being sent through customs.

The number of places available for European, Portuguese speaking countries and International students are limited and reviewed annually by the school's direction.

### EUROPEAN AND INTERNATIONAL STUDENTS UNDER 18 YEARS OF AGE

European and International students under the age of 18, independently of their nationality, have to, in compliance with Portuguese legislation, obtain recognition of their equivalencies in general studies from their country of origin.

The school only admits those who complete 16 years old by the beginning of school year.

Admission and selection of students is by audition, either in presential or alternatively by video submission. The video should include specific sections from classical ballet and contemporary dance class.

Auditions and video applications are assessed by a panel appointed by the school's management.

European, Portuguese speaking countries and International students under 18 years of age are exempt from school fees, however the number of places available are limited and are reviewed annually by the school's management.

It is compulsory for all students to attend all general and artistic classes within their designated school timetables. Students who wish to opt for distance learning or home schooling from their country of origin should present the necessary documents when registering with EDCN.

Students under 18 years of age who are admitted to EDCN may only attend if they have acquired a Portuguese residence permit, that can be requested when applying for accommodation, and have appointed a Tutor residing in Portugal.

EDCN accepts no responsibility for the authorisation of necessary visas and resident permits for European and International students under the age of 18 years who wish to attend the school, as well as meals, accommodation and any goods being sent through customs.
